7.0 Guidance to Support the Review of Long-term Bisphosphonate Therapy in the Management of Osteoporosis

The Chair welcomed Dr Stuart Linton, Consultant Rheumatologist, to the meeting. Before presenting his paper, Dr Linton thanked all contributors. F ollowing his presentation Dr Linton responded to questions from the group and acknowledged recommendations. The paper was well received by the group and it was recommended that it be sent to the Welsh Osteoporosis Advisory Group (WOAG) for comment.

8.0 Polypharmacy: Guidance for Prescribing for Frail Adults

The Chair presented a paper on behalf of Mrs Jenny Pugh Jones**, Chief Pharmacist, Hywel Dda University Health Board. The paper contained 4 items for consideration by this group:

Local (Welsh) data for > 75 years and on 10+ medicines

Local information from three GP practices in West Wales indicates that of the patients > 74 years (from CASPA lists) it is estimated that between 22%–29% of this age group are on 10 or more medicines. Could we obtain more robust data within the timescales?

WAPSU agreed to contact Health Boards to gain additional data. Health board pharmacists asked for clarity on the question being asked to identify the numbers, but were happy to provide the information

ACTION Bev Woods, Fiona Walker to provide data AWTTC to update data

STOPP/START

There is currently no reference in the document to the work that WeMeReC are taking forward around the Screening Tool of Older Person's Prescriptions (STOPP)/Screening Tool to Alert doctors to Right Treatment (START) principles.

It was agreed that there should be reference to this work.

ACTION

New Oral Anticoagulants (NOACs)

NOACs have not been included but does the group feel that it would be appropriate to do so?

It was agreed that there should be a statement regarding NOACs within the document.

Presentation

The summarised charts provided by Aneurin Bevin Health Board (Emyr Jones) have been add ed as appendices as 'Summary Tools' to support implementation. The group discussed this and it was agreed that the charts are very useful and could be moved to the start of the document

ACTION

Consider reviewing document to give more prominence to charts

It was agreed that the document should be sent for consultation on 25th March once the agreed changes have been made.

9.0 Project to Reduce Medicines-related Admissions – Clinical Coding

The Chair welcomed Mrs Janet Thomas, Betsi Cadwaladr UHB. Mr Jamie Hayes informed the meeting that one of the areas to be considered as a result of the discussions held at the previous meeting in December 2013 was clinical coding within hospitals in NHS Wales. He informed the meeting that he and Mrs Thomas had held various meetings with staff responsible for clinical coding to explore and understand the role of clinical coding for medicines related admissions. Mrs Thomas presented 7 different scenarios which were discussed by the group.

10.0 One System for Health

The Chair welcomed Mrs Cheryl Way, NWIS, who gave a verbal update regarding the One System for Health project, which focuses on part of the AWMSG Five Year Strategy for 2013–2018. She informed the meeting that following a successful pilot, the Medicines Transcribing and eDischarge is now available to health boards to use. She also provided an update on the Hospital Electronic Prescribing and Medicines Administration (HEPMA) system.

11.0 British National Formulary Chapter Analysis

Ms Kath Haines introduced the Primary Care Prescribing Data: British National Formulary Chapter Analysis: Eye, Respiratory and Cardiovascular April—September 2013. Miss Karen Jones then presented the data. This was discussed at length by the group and suggestions were made for further analysis and it was agreed that a more detailed analysis of respiratory prescribing would be undertaken, using examples of work undertaken in health boards which may account for differences in prescribing.

ACTION

Health boards to provide any local work undertaken which may account for differences in prescribing.

12.0 National Prescribing Indicators 2014–2015: Supporting Information for Prescribers

Mrs Kate Jenkins informed the meeting that this paper had already been circulated to members for comment and these had been noted. The paper was discussed at length by the group. Dr Tessa Lewis asked if a patient version would be made available – it was suggested that this would be useful, as would providing information to community pharmacists to establish a more consistent message. Several other

recommendations had been m ade by email from Sian Evans. Future formats and resources to be discussed by NPI task and finish sub-group during the development of NPIs. Mr Jamie Hayes recommended to the meeting that this paper would be an ideal educational opportunity for the Wales Centre for Pharmacy Professional Education and he would liaise with Mrs Margaret Allan, Acting Director.

13.0 Wales Audit Office Review of Primary Care Prescribing

The Chair welcomed Mr Malcolm Latham who provided a verbal update regarding the Wales Audit Office Review of Primary Care Prescribing. The All Wales review is nearing completion and is almost ready for circulation. Mr Jonathan Simms asked if the review findings could be broken down to Health Board level. Mr Latham agreed to look into the possibility. Dr Susanna Jacks asked if the review would be taking into consideration the non availability of some medicines. Mr Latham informed her that this was unlikely due to a lack of data.

14.0 All Wales Prescribing Guidance: Smoking Cessation in Primary Care

Mrs Sian Evans presented a paper prepared by Ms Rosemary Allgeier, Public Health Wales. The paper was discussed at length by the group. Dr Richard Greville recommended that the paper be sent to manufacturers for consultation. Mrs Fiona Walker and Mrs Bev Woods informed the meeting that their health boards have their own guidance, as may other health boards in Wales. Mrs Woods agreed to forward the Cwm Taf Health Board guidance to the author.
