3.0 Declaration of interest.

Robyn Miles declared interests pertinent to item 7.6 on the meeting agenda.

4.0 Chair's report

The Chair informed the meeting that there were no items of note to report.

5.0 Minutes of previous meeting

The minutes of the previous meeting were checked for accuracy and agreed.

Kate Jenkins informed the group that the National Prescribing Indicator task and finish group would be meeting at University Hospital Llandough on the 22nd July for consideration of the 2015–2016 National Prescribing Indicators and invited representation.

6.0 Feedback from AWMSG meetings held 2 April, 7 May and 11 June 2014

Kath Haines provided feedback that all the following papers were well supported and endorsed at AWMSG meetings held on 2 April, 7 May and 11 June 2014:

7.0 Documents for discussion

7.1 Role of Oral Anticoagulants for the Prevention of Stroke and Systemic Embolism (TL)

Tessa Lewis presented the paper and consultation responses, which were discussed at some length. Some changes and actions were agreed in light of consultation comments and the remaining recommendations for review will be circulated to the subgroup for comment before requesting e-sign off by AWPAG members.

ACTION: Paper and consultation responses to be sent to sub-group and then e-mail updated paper to AWPAG members for sign off.

7.2 Dose Taper and Discontinuation of Biologics in Low Disease Activity Rheumatology (JP)

The Chair welcomed Jayne Price, Medicines Management Pharmacist, Powys Teaching Health Board to the meeting. Ms Price presented the Dose Taper and Discontinuation of Biologics in Low Disease Activity paper and the project proposals. There were some concerns raised that withdrawing treatment might increase the risk of an immune response on re-challenge with biologics and asked Jayne to seek assurance from Southampton on this issue. The group did not support universal first line biologic treatment, intentionally working outside of NICE, and the proposed financial approach also outlined in the paper. The group were therefore supportive of elements of the proposal with the premise of the clarification, on which Jayne Price will feedback to the group.

There was a suggestion to suggest this as an Invest to Save proposal. It was also suggested that the Southampton group could be invited to speak at AWPAG.

ACTION: Jayne Price to progress project including future consultation with gastroenterologists and feed back to AWPAG.

ACTION: Sarah Isaac to forward link to British Society for Rheumatology paper for inclusion in doc.

7.3 Prescribing Dilemmas: Erectile Dysfunction (TL)

Tessa Lewis presented an update to the Prescribing Dilemmas paper. The group considered a partial update to the prescribing dilemmas paper and agreed that the whole paper required review. The Chair asked for volunteers to review sections and these were agreed as follows:

7.5 Guidance to Support the Review of Long-term Oral Bisphosphonates (SL/TL)

The Chair welcomed Dr Stuart Linton to the meeting. Dr Linton presented this paper and informed members that the paper had now been reviewed by the Welsh Osteoporosis Advisory Group (WOAG). Minor changes had been made following this. Kate Jenkins gave a verbal summary of three pilot audits which had been undertaken and recommended some areas of clarification, along with additional links and the addition of data collection guidance. Discussion followed and some amendments proposed and agreed, including an amendment to the title, the addition of links, and

clarification on fragility fracture. Discussion also followed regarding the development of a national audit, which would cover data collection guidance.

ACTION: Amendments to be made and paper to be sent out for consultation, followed by e-sign off.

7.4 Antibiotic Audit Outcomes (TL)

Tessa Lewis presented a summary of the Antibiotic Audit Outcomes. Discussion followed with regard to the responses to the audit. It was suggested that low response numbers may be due to failure to report, rather than failure to audit. It was suggested that a centralised tool to electronically collect data would be useful.

ACTION: AWTTC to recirculate to obtain further information, disseminate results and promote audit further.

Andrew Evans and Sarah Isaac left the meeting. Karen Jones joined the meeting.

7.6 BNF Chapter Analysis: Respiratory Therapeutic Area (KJ)

Kath Haines introduced Primary Care Prescribing Data: British National Formulary Chapter Analysis: Respiratory Therapeutic Area. It was agreed to change the title of the paper to better reflect the specific respiratory therapeutic area analysis. Karen Jones presented the paper in more detail; amendments were suggested and agreed.

ACTION: Insert additional information in the paper and put out to consultation to MTCs, Prescribing Leads, Chief Pharmacists, Medicines Management Groups, Primary Care Prescribing groups.
